ACKNOWLEDGEMENT AND CONSENT

This is an important document which affects your legal rights and obligations. You are required to read it carefully prior to participating in the event with your child or ward. Please read this form prior to the event to be aware of the risks of participating.

In consideration of Kallang Alive Sport Management Co. Pte. Ltd. ("Organiser") accepting my and/or my child's or ward's participation in AirAsia Kallang Run ("Event") to be held on **27 September 2025.** I agree to this release of claims, waiver of liability and assumption of risk.

- 1. I have read and understood the Even Safety Regulations relating to the Event.
- 2. The Organiser may, at its sole discretion, refuse entry or cancel an entry for any person, including my child or ward, for any reason whatsoever.
- 3. I understand the demanding physical nature of the Event. I declare that, to the best of my knowledge, my child or ward is in good physical health and is able to safely engage in sustained, high-intensity physical activity as required by the Event. I am not aware of any illness, injury, or other physical condition that may cause injury or death while participating in the Event.
- 4. In the event that I, my child or ward become aware of any medical condition, impairment, or illness prior to or during the Event, I will ensure that my child or ward withdraws from participation.
- 5. I acknowledge that participation in the Event involves certain risks for my child or ward and I, and I accept full responsibility for those risks.
- 6. I acknowledge and understand that whilst participating in the Event:
 - a. I, my child or ward may be injured, physically or mentally, or may die from various causes including, but not limited to over exertion, dehydration, cardiac arrest, slips, trips or falls, accidents with other participants, spectators and road users, or accidents caused by my own actions;
